Dear DEP Air Permit Holders:

The purpose of this letter is to remind you that the Annual Operating Report (AOR) for the 2020 reporting year is due by **April 1, 2021**. There have been no changes to the software for the electronic AOR (EAOR), therefore, please continue to use the same EAOR software as was used last year to complete your 2020 AOR. Please note that reporting year 2020 is a hazardous air pollutants (HAP) reporting year. The additional requirements for reporting hazardous air pollutants in a HAP year are specified in the AOR Instructions of DEP Form 62-210.900(5)

Submittal of your AOR using the EAOR software fully satisfies the AOR requirement thus making hardcopy submittal unnecessary. Although all Title V sources must use the EAOR software, we strongly encourage non-Title V sources to also take advantage of the benefits of the EAOR software to submit their AOR.

Title V Fees (for Title V Sources Only)

Annual emissions fees are collected by the Department from Title V major sources of air pollution. The fees are based on the actual amount of regulated air pollutants emitted and are automatically calculated upon submittal of the EAOR to the Department. The Title V emissions fee must be post marked or received by **April 1, 2021** to avoid a penalty. The Annual Emissions Fee payment and Invoice should be sent by regular or certified mail to:

Checks are made payable to “**Florida Department of Environmental Protection**”.

Please include the ‘**EAOR Title V Annual Emissions Fee Invoice**’ with the check.

Note: Title V Fees must be post marked or received by April 1 or a **late penalty** of 50% of the amount of the regular fee shall be imposed. Note: Forms of payment include checks or wiring transfer of funds only (payment by credit card is not available).

EAOR Website

The EAOR website will be updated by January 8, 2021 with resources and other information to help you complete your 2020 AOR: <https://floridadep.gov/air/permitting-compliance/content/annual-operating-report>.

- EAOR software: The EAOR software, version 2018-1, is available on the EAOR website for download. However, please note, your 2020 AOR file will be available for import into the EAOR software by approximately January 6th. It is encouraged you review your data file to ensure that it is accurate prior to completing it.
- Download or request a partially pre-filled hardcopy AOR form (hardcopies are for non-Title V sources only, unless claiming a hardship as defined in AOR rule).
- AOR Submittal Search webpage lists EAORs received by DEP and includes submission receipts, e-signature date, and for Title V sources, an emissions fee Invoice.
- Solutions for common EAOR software or submittal errors.
- Information on the AOR Training webinar to be held in late January will be posted.
- Title V fee factor for reporting year 2020 is \$30.
- Tutorial summarizing Title V fees in the EAOR software.
- 'Frequently Asked Questions' answers common general questions and also provides methods for submitting new questions.
- Flow chart to determine the pollutants that must be reported.
- EAOR user manual.

Benefits of EAOR Software

The EAOR software is designed to make reporting less time-consuming and more efficient by enabling you to:

- Submit and sign your report electronically via the Internet.
- Avoid errors by pre-filling facility-specific information from the Department's database.
- Have a side-by-side comparison of this year's data with the data from previous years.
- Set formulas to calculate emissions that can be re-used with future reports.
- Attach supporting documents electronically.
- Identify missing data via the edit checks feature.
- Save your report as a .PDF file for your records.
- Automatically calculate Title V fees based on the AOR emissions (Title V sources only).

Signature – Electronic or Hard Copy (only one signature method is necessary)

For electronic signature, if you do not have an air account and PIN for either EAOR or EPSAP, then please see the instructions for obtaining one at the above-referenced EAOR website. You do not need to download EAOR software in order to e-sign your AOR. Hardcopy signature pages are not necessary to be submitted if the AOR is electronically signed. However, if you are not using electronic signature to sign the AOR, then please either attach the signature pages in your EAOR (i.e. sending them with your EAOR submission), or, see below for where to send us the signature pages based on whether your facility is Title V or non-Title V.

AOR Submittal

EAOR software has a direct submittal feature. However, if you are unable to use the direct submittal feature of the software, you can still use the EAOR software to prepare the report, as

well as the Department's website to electronically sign the report. If you prepared the report using the EAOR software, however are unable to submit it to DEP (due to firewall issue, etc.) then you will need to email the file which has a **.sub** file extension, to the Department at EAOR@dep.state.fl.us (If the .sub file is too large to email, then you may download the submittal file to our incoming FTP site: <ftp://ftp.dep.state.fl.us/pub/incoming>).

If you are a **Title V** facility, then you must use the DEP's EAOR software, unless claiming a technical or financial hardship by submitting DEP Form No. 62-210.900(5) to DEP.

A **Title V** facility submitting a hardcopy AOR form or only the first two pages with the signature page signed, should email the scanned version to DEP at EAOR@dep.state.fl.us or send by regular mail to the following address (Note, during Covid, email is preferred):
