The BMAP was developed with the support of many local entities and jurisdictions, such as: Bayou Chico Association, Escambia County, Escambia County Health Department, Emerald Coast Utility Authority (ECUA), FDEP, FDOT, City of Pensacola, US Naval Air Station, and Northwest Florida Water Management District. The adopted BMAP identifies specific programs, projects, and activities to address the source of fecal coliform to Bayou Chico (e.g., sanitary sewers, stormwater, OSTDS, marinas, boatyards and moorings).
