If these values are not within 20%, the final field measurement value will be qualified as being estimated with an F value qualifier.

$$\text{RPD} = \frac{(\text{Highest Value} - \text{Lowest Value})}{(\text{Mean Value of Highest and Lowest Values})} \times 100\%$$
