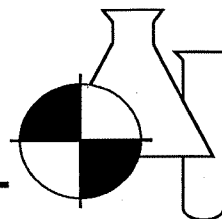

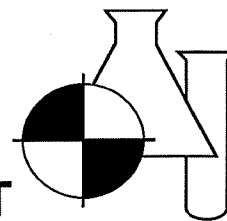

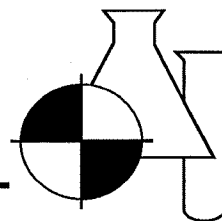

- The client is responsible for documentation of the sampling event. Please note special sampling events on the sample custody form.
