CASE NARRATIVE

All analyses were performed consistent with the quality assurance program of ALS Environmental. This report contains analytical results for samples for the Tier I level requested by the client.

Sample Receipt:

Seven water samples were received for analysis at ALS Environmental on 07/15/2020. Any discrepancies upon initial sample inspection are annotated on the sample receipt and preservation form included within this report. The samples were stored at minimum in accordance with the analytical method requirements.

Microbiology:

Method ASTM D6503-99: Sample(s) J2003640 (1-7) were removed from the incubator and read on 7/16/20 1622.

Method ASTM D6503-99: Sample(s) J2003639 (1 AND 2) were received with insufficient hold time remaining to complete the analysis within the recommended limit. The analysis was performed as soon as possible after receipt by the laboratory. The data is flagged to indicate the holding time violation.

Method SM 9222 D: Sample(s) J2003639 (1-7) were removed from the incubator and read on 7/16/20 1435.

Results for sample(s) J2003639 (1,3,5,7) are based on colony counts outside the optimal range of 20-60 CFU. The data has been qualified. This is an informational flag and does not impact the quality of the data.

Method SM 9222 D: Sample(s) J2003639 (1-3) were received with insufficient hold time remaining to complete the analysis within the recommended limit. The analysis was performed as soon as possible after receipt by the laboratory. The data is flagged to indicate the holding time violation.
