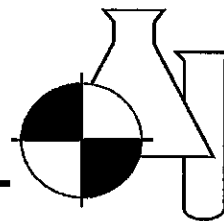

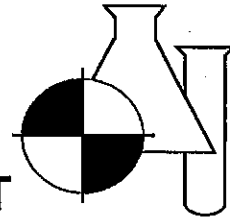

Sample Type is used to indicate whether the sample was a grab (G) or whether it was a composite (C).

Sample Matrix is used to indicate whether the sample is being discharged to drinking water (DW), groundwater (GW), surface water (SW), fresh surface water (FSW), saline surface water (SSW), soil, sediment (SDMNT), or sledge (SLDG).

Container Type is used to indicate whether the container is plastic (P) or glass (G).

Sample must be refrigerated or stored in wet ice after collection. The maximum temperature during storage should be 6°C (42.8°F). Under "Preservative," list any preservatives that were added to the sample.

Instructions:

- Each bottle has a label identifying sample ID, preservative, container type, date ID, and parameters for analysis.
- The following information should be added to each bottle label after collection with permanent black ink: date and time of collection, sampler's name or initials, and any field number or ID.
- All bottles not containing preservative may be stored with appropriate sample prior to collection.
