SMP Project

Login Protocol February 14, 2021

The SMP project can't (with certain exceptions) use either Y or Q qualified data and would rather have Receiving not login these samples. It's considered a waste of laboratory resources to analyze affected samples that will be qualified, and their data will not be used by the SMP project.

1. If the sample set contains an SCI login all bottles and run all tests regardless of hold time or temperature issues.
2. The SMP project does not want "Y" qualified preserved nutrients, unpreserved nutrients, microbiology, Chlorophyll, or metals data. (I.e. preservation NCR; acid or ice).
 - Preservation Exception: qPCR and organic samples (They still want these data)
 - Preservation NCR ("Y" qualifier) are acceptable for temperature and chlorine detections for these analyses.

Note: Unpreserved metals samples may be preserved/acidified in the lab upon receipt and do not need to be qualified if they are analyzed 24 or more hours after acidification.

3. The SMP project does not want "Q" qualified preserved or unpreserved nutrients data. (I.e. Out of hold time).
 - This includes chlorophyll that are greater than 48 hrs.
 - Hold Time Exception: microbiology, qPCR, and organic samples (They still want these data)
 - Out of hold time ("Q" qualifiers) are acceptable for these analyses.

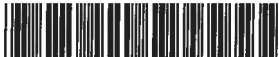
