Sorry for the delay. I am just getting back to the office from the field. You are correct.

G2SE0059 is scheduled as a freshwater matrix (E. coli.) correctly, but it is one of those cases of elevated salinity in a waterbody classified as freshwater as per SMP.

The Sp. Conductivity recorded in the field was correct (23,689 umhos/cm) and corresponding salinity (14.33 PPT).

Hope that helps! If you have any other questions I will be around the office the rest of the day.
