3. The label identifying sample ID, premeasured preservative contained in the bottle, sample type, client ID, and parameters for analysis.
4. The label on the bottle should be attached to each bottle, both after collection with permanent black ink, date and time of collection, sampled's name or initials, and any field number or ID.

Preservation:

1. "Sample Matrix" is used to indicate whether the sample is being dispatched to drinking water (DW), groundwater (GW), surface water (SW), fresh surface water (FSW), saline surface water (SSW), soil, sediment (SDMNT), or sludge (SLDG).
2. "Container Type" is used to indicate whether the container is plastic (P) or glass (G).
3. Sample must be refrigerated or stored in well ice after collection. The maximum temperature during storage should be 6°C (42.8°F). Under "Preservative", list any preservatives that were added to the sample container.
