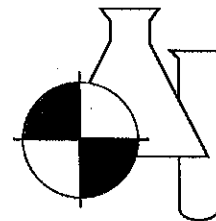

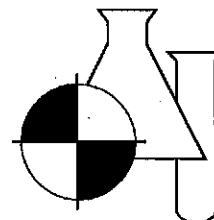

- \*Container Type is used to indicate whether the container is plastic (P) or glass (G).
- \*Sample must be refrigerated or stored in wet ice after collection. The maximum temperature during storage should be 6°C (42.8°F). Under "Preservative" list any preservatives that were added to the sample container.
- \*Each bottle has a label identifying sample ID, preservation process, volume in the bottle, sample type, client ID, and preservatives for analysis.
- \*The following information should be added to each basic label after collection with permanent black ink: date and time of collection, sampler's name or initials, and any field number or ID.
- \*All bottles not containing preservative may be rinsed with appropriate sample prior to collection.
- \*The client is responsible for documentation of the sampling event. Please use special sampling events on alternate custody form.
