SEMINOLE ELECTRIC COOPERATIVE'S MOTION FOR EXTENSION
OF TIME TO RESPOND TO SIERRA CLUB'S EXCEPTIONS TO
PROPOSED RECOMMENDED ORDER ON LAND USE AND ZONING

By and through its undersigned counsel, Seminole Electric Cooperative Inc. files this Motion to extend the date for the filing of Seminole's responses to the Sierra Club's Exceptions to the Recommended Order on Land Use and Zoning. Those Exceptions were filed by Sierra Club with the Department of Environmental Protection on September 28, 2006. While those Exceptions were not timely filed with the Department of Environmental Protection as Clerk to the Siting Board, Seminole Electric agreed not to object to the Sierra Club's late filing of those Exceptions with the Department. Sierra Club and Seminole also agreed that Sierra Club would not object to a 14 day extension for Seminole to file its responses to those exceptions. Sierra Club made that representation in its Amended Motion for Extension of Time. Only Seminole Electric and Sierra Club filed proposed recommended orders; Seminole Electric did not file any exceptions to the Recommended Order.


Seminole Electric restates here that it does not object to the late filing of exceptions by Sierra Club on September 28, 2006.

To avoid any confusion over the deadline for the submittal of Seminole Electric's responses to those Exceptions, Seminole Electric requests that the deadline for submittal of Seminole Electric's responses be set as 14 days from the filing of Sierra Club's Exceptions, or October 12, 2006. This will extend the deadline from the 10 days for responses to exceptions under Rule 26-106.217(2), F.A.C. to 14 days from submittal of Sierra Club's Exceptions.
