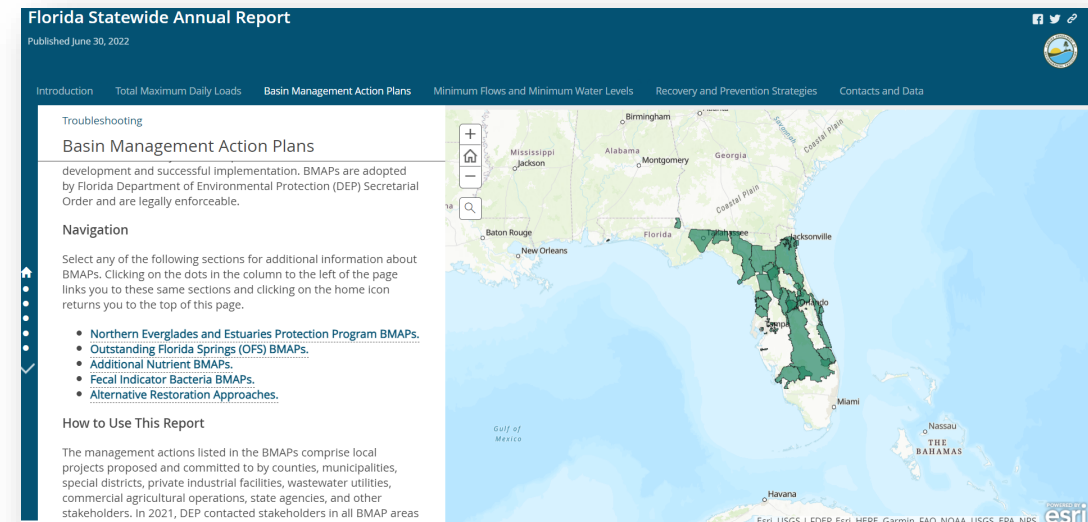


STATEWIDE ANNUAL REPORT (STAR)

JUST A REMINDER

- Requirement under Section 403.0675 Florida Statutes (F.S.) to provide an annual update to the Governor and Legislature.
- Summarizes accomplishments in the BMAPs statewide.
- Reports on restoration projects and management strategies.
- All BMAP reporting periods align with calendar year.
- Submitted to the Governor and the Legislature by July 1 of each year.
- Viewable as interactive story map.

- Compliance

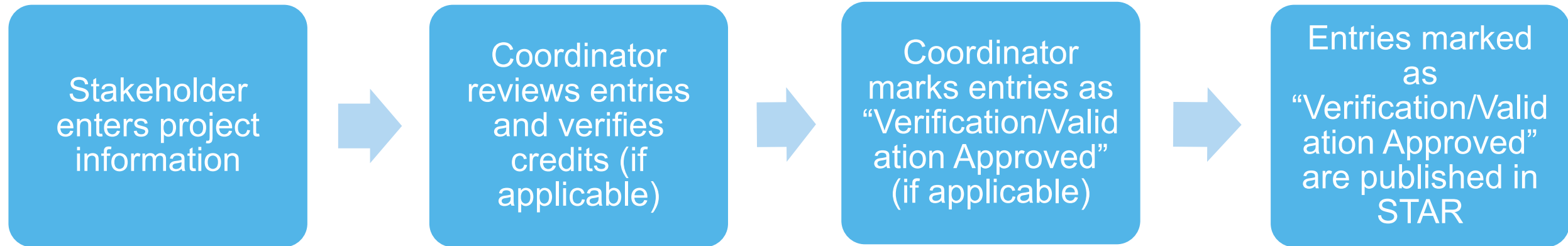
TRAINING

- We encourage everyone to contact their BMAP Coordinator for guidance as you become familiar with the portal.

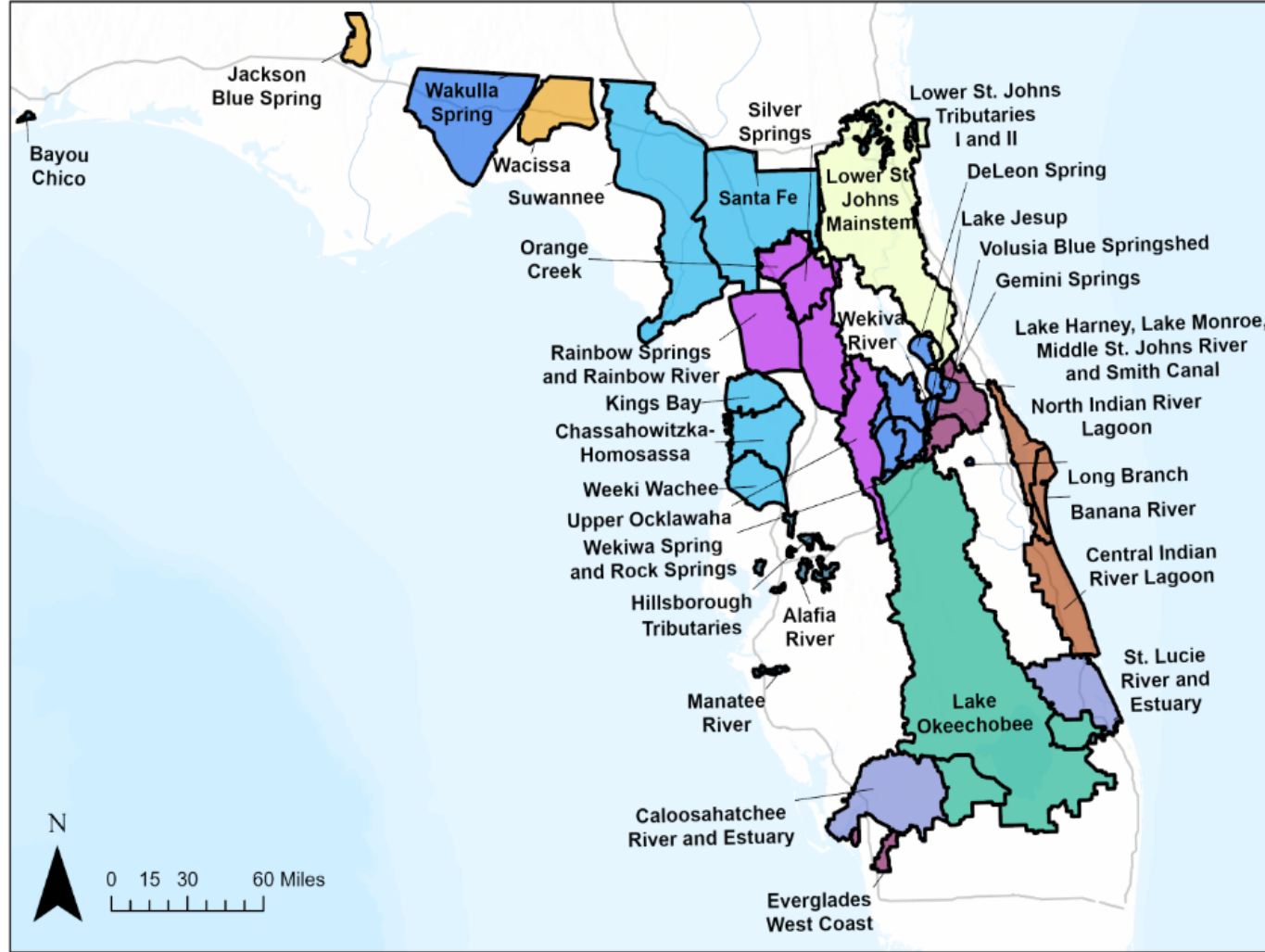
