Big Cypress Swamp Advisory Committee Meeting to discuss Trend Exploration Oil and Gas Application

This is a meeting of the Big Cypress Swamp Advisory Committee (BCSAC) convened by the Department of Environmental Protection (DEP). The BCSAC was established to ensure compliance with all requirements for obtaining a permit to drill a well to explore for hydrocarbons in the Big Cypress Swamp area pursuant to Chapter 377, Florida Statutes (F.S.) and Chapters 62C-25 through 62C-30, Florida Administrative Code (F.A.C.). The committee is meeting to evaluate and provide recommendations on a pending permit application submitted by Trend Exploration LLC (Trend) for a project to drill and explore for hydrocarbons at a location near Immokalee, Florida within the Big Cypress watershed. The BCSAC shall administer its charge pursuant to the laws of the state, and the rules and orders of the Department which apply generally to oil and gas. If site-specific conditions require, the committee may recommend that additional procedures, safeguards, or conditions which are necessary to protect the integrity of the Big Cypress area be required as a condition to the issuance of a permit to drill and produce.
