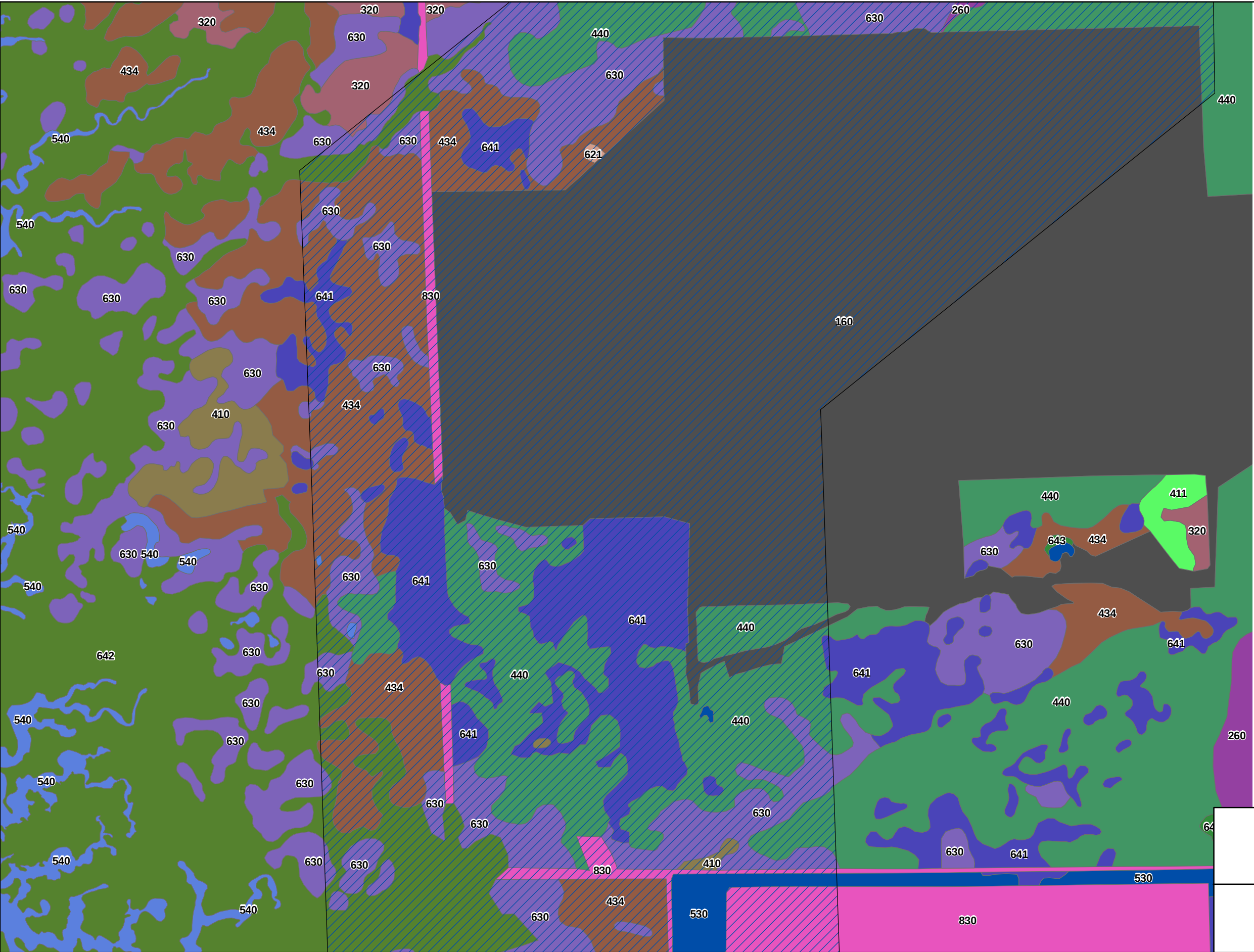

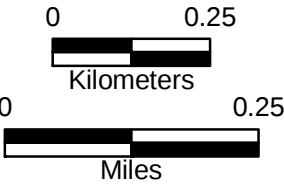

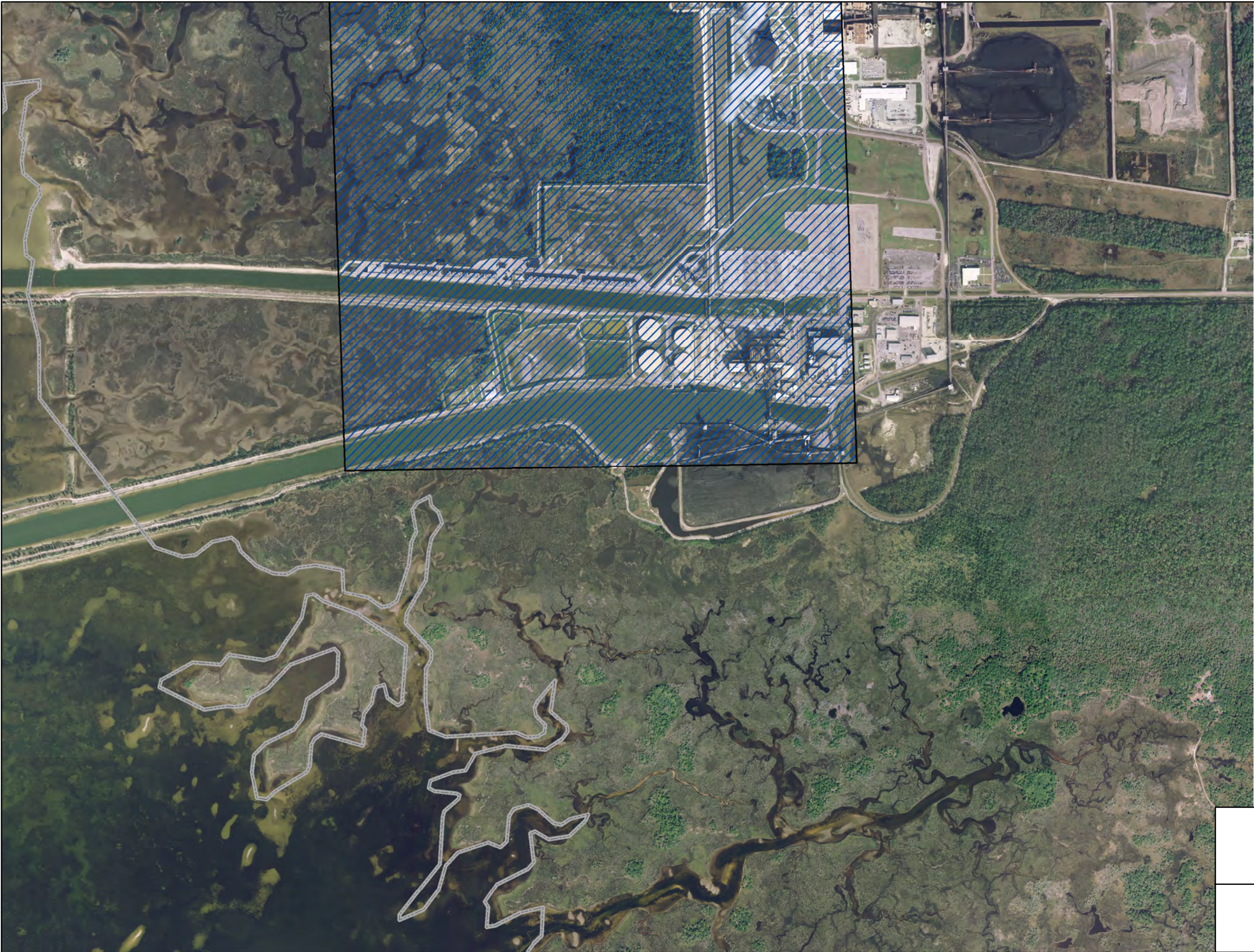

Classification System Level III



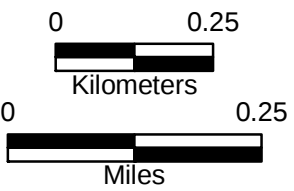
