Dear Mr. Raffenberg:

On November 12, 2012, the Florida Department of Environmental Protection (Department), Siting Coordination Office received a request from Florida Power & Light Company (FPL) for a post-certification amendment to the Martin Next Generation Solar Energy Center (FPL Martin) Site Certification Application (SCA). The amendment request was for the inclusion of the Riviera Lateral Martin Gas Yard associated with the Riviera Beach Energy Center (RBEC) Phases I and II pipeline project and connection points for future infrastructure within the facility's certified area. On December 7, 2012, the Siting Coordination Office issued an amendment approval letter for the project.

The purpose of this letter is to clarify that although located wholly within the boundaries of the FPL Martin site, the Riviera Lateral Martin Gas Yard is considered an off-site associated facility of the RBEC as it is in support of that facility. Amendment approval (AM12-042) was issued to FPL for the Martin plant for the material changes that occurred on that site. The Riviera Lateral Martin Gas Yard was contemplated in the RBEC February 28, 2012 petition for modification for the RBEC Phase II Pipeline Project (PA 09-54C).
