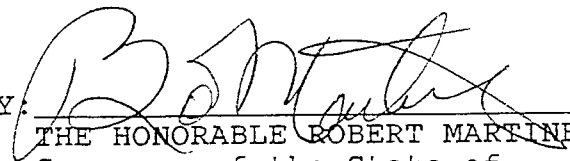
ORDERED;

1. The Modification to the Conditions of Certification as agreed to by all parties to the original certification proceeding pursuant to Section 403.516(1)(b), Florida Statutes, is approved and adopted.

2. No determination is made on the accuracy of the Whereas clauses contained in the Stipulation. It is acknowledged that certain statements in the Whereas clauses are the subject of ongoing litigation unrelated to the effect of this modification. It is intended that this approval of the modification shall have no effect on such litigation.
