Project Description
Blind Pass is located between Sanibel and Captiva Islands. The project site includes the Gulf of Mexico shoreline between R-110 and R-118 on Sanibel Island in Lee County, Florida. Prior to the opening of Redfish Pass in 1921, Blind Pass was a more substantial inlet with a larger tidal prism. The Blind Pass ebb shoal associated with the larger tidal prism most likely helped maintain the seaward position of the south end of Captiva Island and the north end of Sanibel Island. In December 2008, Lee County began dredging to re-open Blind Pass, which was completed on July 31, 2009. With ongoing maintenance dredging, the pass has remained open and the dredge material has been placed downdrift on Sanibel Island. Lee County and DEP sponsored an inlet management study of Blind Pass, which compiled new and historical data and information regarding its coastal processes and inlet and shoreline dynamics, updated its sediment budget, and developed feasible alternatives for the mechanical transfer of sand from the inlet to the beaches south of the inlet. Project is a Feasibility study. And LS determined that the project is eligible for 50% state cost share.
