SUBJECT: Approval of the Rehabilitation Effort for the St. Johns County, FL Coastal Storm Risk Management Project, St. Augustine Beach Reach

1. References:

2. Reference 1.e. has been reviewed in accordance with the criteria set forth in References 1.a., 1.b., 1.c., and 1.d.

3. The Project Information Report (PIR) in reference 1.e. demonstrates that an "extraordinary storm" occurred as evident from the storm characteristics of the Nor'easter which occurred from 5 to 6 November 2021 and resulted in significant damages. The extraordinary storm declaration and recommended alternative are approved.

4. The economic justification in this PIR demonstrates a positive project benefit to cost ratio. If the total projected FCCE cost exceeds \$38,000,000, then a resubmittal to CECW-HS with updated information for approval will be required.
5. Funding for this rehabilitation will be subject to the prioritization and availability of FCCE funds. Unless otherwise approved by CECW-HS, transmitted FCCE funds may only be retained for a period no later than 180 days from project physical completion.
