| <p>The Central Boca Raton Beach Nourishment Project is located between DEP monuments R216 and R222 in Palm Beach County. The roughly 1.45 mile long project completed its first restoration in March 2017. The next renourishment is currently scheduled for FY28/29 in conjunction with the North Beach federal nourishment. Physical monitoring of the Central Boca Raton Beach occurs annually in conjunction with the City Wide beach and shoreline monitoring (beginning in 2024). The requested funds are for 9th year post-construction monitoring for the 2017 restoration. Staff have determined that 84.64% of the project is eligible for state cost sharing.</p> |
