Carl Gray Park is one of Panama City's oldest parks. It sits on the bayou at the mouth of North Bay. The park provides a public launch for boats as well as picnic areas and playgrounds. It is also adjacent to Gulf Coast State College and hosts a number of fairs and festivals. This project will provide additional recreational and fishing opportunities regardless of age, race, gender, or economic status and help the area recover from the negative impacts from the Deep Horizon Oil Spill. This project seeks complete replacement of the boat ramp.

The estimated construction cost for all aspects of this project is \$618,700.00. An Engineer's Cost Opinion is included in this application.

### Anticipated Project Outcome with Respect to Screening Criteria

The oil spill caused extensive damage to marine and wildlife and to the Gulf's fishing and tourism industries. The oil spill notably hindered recreational fishing and boating within the Panama City area. These improvements to the Carl Gray Park Boat Ramp will provide the additional opportunities needed for recreation and fishing opportunities to be enjoyed by the residents and visitors to the Park.

The City of Panama City owns Carl Gray Park and therefore, no right of way or temporary easements have to be acquired. The Design and permitting is not completed, but could be within 6 months of funding availability.

Preble-Rish has relevant past experience with similar projects.

**Anticipated Project Outcome with Respect to Evaluation Criteria**

**E1. Will restore, rehabilitate, or replace a natural resource or service<sup>1</sup> believed/demonstrated to have been injured as a result of the Deepwater Horizon oil spill or associated response activities:** *(Briefly describe the nature of any relationship between the new/improved resources or services and those adversely impacted by the oil spill.)*

Panama City has a robust commercial fishing industry that catches and distributes hundreds of thousands of dollars worth of seafood weekly to restaurants and vendors all over the United States. This industry was shuttered due to the spill from May to December 2010. Additionally local charter fishing and tourist excursion boat businesses were closed during spill response. The Port of Panama City lost 80% of its orders during this period, and the area's tourism decreased 70%. These negative economic impacts multiplied throughout the community. This project will aid in restoring fisheries and human use critical to the local economy. This boat ramp has met the end of its useful life and its replacement will allow for human use of the Gulf.

Carl Gray Park is located on the bayou at the mouth of North Bay and off of the Gulf of Mexico which was injured by the Deepwater Horizon Oil Spill. This project would benefit users of the Gulf as well as the City of Panama City as it will provide a public boat ramp for the residents and tourists of the City of Panama City.

Design and permitting for the Project have not been completed, but could be within 6 months of funding availability.

These improvements will provide additional recreational and fishing opportunities for residents and tourists regardless of age, race, gender or economic status and help the area recover from the negative impacts created by the Deep Horizon Oil Spill.
