Brief Project Narrative: *(Describe what the project will do.)*

Mashes Sands Beach area does not have a dedicated canoe/kayak launch area and currently canoes and kayaks are launched from beach areas nearby and where parking is not available. This can result in damages to the beach area and vegetation from canoes and kayaks being dragged from the parked vehicle to the water for launching. This project will be to construct two dedicated launch facilities as depicted in the Conceptual Master Plan for the Mashes Sands Park. A dedicated launch pad would provide for better experience for beach goers by directing kayakers and canoers to a designated area for launching, especially one with appropriate signage and education information about the area. This project will help to stabilize and beautify the beach area making it more attractive to visitors, encouraging tourism and stabilizing the environment for native vegetation, wildlife and marine life.

Mashes Sands is the collective name for a complex of low dunes, sandy beach and a shallow offshore flat of rippled, sandy shoals. It is surrounded by three bodies of water; the Apalachee Bay, Dickerson Bay, and the Ochlockonee Bay, offering both salt and fresh water access. Due to its proximity to other surrounding counties, people venture out to the Park for outdoor recreational activities. Nature observation for marsh and shore birds and waterfowl is ideal year round. Fish commonly caught in the area are mullet, redfish, speckled trout, white trout, and flounder, fishing in the Ochlockonee River offers many freshwater species. While no records of marine turtle nesting have been found for the Park, it is not impossible that should proper beach conditions be present, a marine turtle nest might occur. Vegetation is diverse due to the salt and fresh water bodies. Wildlife can be observed feeding on the many different species of fruits and flowers. The Park is a State owned property leased to Wakulla County since 1983, for the purpose of outdoor recreation. Local and Regional Impact: The Park is included in what is known as the "Ochlockonee Barriers" a 22.1 mile stretch of beaches extending from Turkey Point, Franklin County to the St. Marks River, Wakulla County. Within this area is an important regional network of federal, state and private conservation lands including the St. Marks National Wildlife Refuge, Apalachicola National Forest, Tate's Hell State Forest, Ochlockonee River State Park, and Phipps Preserve. This chain of parks and conservation lands provides a regional variety of resource-based recreation opportunities and represents nearly every outdoor recreational user.

This application, for a Canoe/Kayak Launch, is needed because currently the Park does not have a designated launch pad. To provide for a better experience to all beach goers and to protect the environment, it is important to provide for a designated launch site with proper signage. This project will require site location at the Park, design, survey, permitting and construction

It is estimated that this project could cost \$408,000 based on planning level cost estimates. This estimate is based on standard unit costs and other similar projects that were constructed in the area. These costs were calculated by County staff and the County's professional consultants volunteering their services.

Anticipated Project Outcome with Respect to Screening Criteria

Wakulla County has a great amount of experience with this type of project. In fact, the County constructed the existing boardwalks in Mashes Sands Park which will be very similar in construction techniques and permitting. The County plans to use a professional engineer to design and permit the new launch facilities in two locations as depicted on the Conceptual Master Plan for Mashes Sands Park. This will involve design, permitting and CEI to support the construction services.

This project would provide a dedicated canoe/kayak launch pad that would work toward stabilize the beach, providing for better experience for beach goers as well as helping to improve the native vegetation and wildlife habitat.

Anticipated Project Outcome with Respect to Evaluation Criteria

E1. Will restore, rehabilitate, or replace a natural resource or service¹ believed/demonstrated to have been injured as a result of the Deepwater Horizon oil spill or associated response activities: *(Briefly describe the nature of any relationship between the new/improved resources or services and those adversely impacted by the oil spill.)*

Wakulla County, like the other 7 counties from Escambia County to Wakulla County, experienced negative perceptions leading to a decline in tourism, sports fisherman, and seafood sales. The County continues to experience some negative perceptions and concerns for the health and of its seafood, including that of the ecosystems/habitats required for local species to live and thrive.

E2. Is located in, or nearby, resources or services injured by the deepwater horizon spill: *(Briefly describe where the project would be implemented with respect to past/ongoing remediation work.)*

These projects are located in the area of the deepwater horizon spill.

E3. Is ready for implementation, e.g., design, permitting, and necessary impacts assessments have been completed: *(Briefly describe where in the permitting process the project stands along with an estimated date of when the project can be implemented if it is not currently ready.)*

Much in-kind work has been completed for this project by volunteers, County staff and its elected officials. Some of the County's consultants volunteered to provide information and planning services to assist with visioning future improvements and to determine the planning-level costs for the project. The Conceptual Master Plan (enclosed) depicts much of this body of work. Currently, the County does not have the funding to move forward with the beach restoration project as outlined in this application. It is the hope of the County that funds from this application be used for engineering design, permitting and construction. Cost estimates for this project, as stated above were done through volunteers and costs for recent unrelated projects.

¹ In this form, "Services" (or "natural resource services") refers to the functions performed by a natural resource for the benefit of another natural resource and/or the public. This project is highly cost effective since this area represents one of the most high-profile beach access points in Wakulla County. Mashes Sands Park represents the County's attempt at ecosystem and environmental restoration since this area was originally intended for residential development. Due to the efforts of the County and through previous funding and grant opportunities, Wakulla County was able to make significant strides in restoring the area closer to its original condition. Much of the beach areas, wetlands, marsh areas and tributaries are in much better condition than they were some years ago. Efforts to improve access to the beaches and limited impervious surfaces have resulted in very low impact to the natural environment. This project is very cost effective since it will be partially maintained as a result of relatively low cost user fees, and low maintenance facilities. However, this area will have a very high benefit to the community as it will foster opportunities for interactions with the unique natural environment. These launch facilities are needed since the County does not have any other similar facilities nearby.

E5. Has a high potential for long-term success as demonstrated by incorporating established/reliable methods and technologies: *(Briefly describe if/how critical methods and technologies that will be used to implement the project could be considered reliable or proven.)*

Prior to the oil spill, this park was used widely by boaters, fisherman and people using the existing board walks and beaches. As a result of the oil spill, much of those users went away. The canoe and kayak launch facilities improvements will bring those users back and with the new bike trail and an increase in ecotourism, there will be a need to charge a user fee. There are many similar facility projects that can be sited and many of these are located in Florida. These similar projects can be used for estimated project costs and they are very similar in permitting requirements. In summary, these types of projects have been completed recently in Wakulla County and there are multiple contractors who would be expected to bid on such a project.

E6. Is likely to provide benefits rapidly following implementation: *(Briefly describe the anticipated change in benefits anticipated over time.)*

It is believed that this project would should immediate results and benefits to the economy of County as well as the environment. The County has a new and ongoing program of advertising and promoting the County as an ecotourism destination. Recently, the County produced the first smart phone app for use to promote the County's ecotourism and recreational facilities. This effort has resulted in increased visitors. The County expects that with the improvements to Mashes Sands Park, it will then have a new beach destination that will be a major attractor to the surrounding counties and the region. For the metropolitan area of Tallahassee which is to the north, the closest beach right now is nearly two hours away by car. This recreational and beach area would only be about 40 minutes by car. This project would have a significant and immediate positive impact on Wakulla County and the surrounding region. It should also be noted that this launch facility project is just one component of the overall plan for Mashes Sands Park. As depicted in the Conceptual Master Plan there are many other facility improvements that are ongoing which further emphasizes the need for this project.

Through community visioning efforts and a community survey that was conducted, there is a high-level of support for this project. Ecotourism opportunities are a key component to the County's vision of creating the County as a National and International destination. The County desires to improve all aspects of its natural environment and the citizens of Wakulla County know that this is its greatest resource. It is believed that this project will greatly benefit the overall park and because of the immediate results to increasing visitors to the beach for the beach, wildlife and the total nature experience offered at Mashas Sands Beach area.
