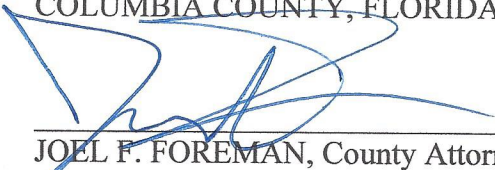
COLUMBIA COUNTY, FLORIDA’S, AGENCY REPORT

COMES NOW, COLUMBIA COUNTY, FLORIDA, a political subdivision of the State of Florida (the “County”), by and through its undersigned counsel, pursuant to Fla. Stat. §403.526(2)(a), and submits the following report regarding the above-referenced transmission line siting (“Project”):

1. Counsel for the County has reviewed the Request for Assignment of Administrative Law Judge filed by the State of Florida Department of Environmental Protection (“Department”), the Order Establishing Schedule dated the 1st day of February, 2016, and other pleadings filed herein to date.
2. The County has further reviewed maps showing the planned Raven Substation site location, project location, the existing transmission line, and the proposed transmission line corridor.
3. The undersigned has had contact with counsel for Florida Power and Light Company.
